REYNOLDSBURG CITY SCHOOL DISTRICT

SHALL BONDS BE ISSUED BY THE REYNOLDSBURG CITY SCHOOL DISTRICT FOR THE PURPOSE OF ACQUIRING REAL ESTATE FOR SCHOOL PURPOSES, CONSTRUCTING, REMODELING, IMPROVING AND ADDING TO BUILDINGS FOR SCHOOL PURPOSES, FURNISHING AND EQUIPPING BUILDINGS FOR SCHOOL PURPOSES AND EQUIPPING AND OTHERWISE IMPROVING SCHOOL SITES IN THE SUM OF FIVE MILLION FIVE HUNDRED THOUSAND DOLLARS AND A LEVY OF TAXES BE MADE OUTSIDE OF THE TEN MILL LIMITATION ESTIMATED BY THE COUNTY AUDITOR TO AVERAGE FOUR AND ONE-TENTH MILLS FOR EACH ONE DOLLAR OF VALUATION, WHICH AMOUNTS TO FORTY-ONE CENTS FOR EACH ONE HUNDRED DOLLARS OF VALUATION, FOR A MAXIMUM PERIOD OF TWENTY-THREE YEARS TO PAY THE PRINCIPAL AND INTEREST OF SUCH BONDS?




