PROPOSED INCREASE IN CITY INCOME TAX

CITY OF HILLIARD

(A MAJORITY AFFIRMATIVE VOTE IS NECESSARY FOR PASSAGE)

SHALL ORDINANCE NO. 85.07 OF THE CITY OF HILLIARD BE PASSED TO AMEND SECTIONS 91.02 AND 91.17 OF THE HILLIARD CITY CODE AND TO PROVIDE FOR A TWO PERCENT PER ANNUM LEVY ON INCOME, WHICH IS AN INCREASE OF ONE-HALF PERCENT ANNUM; THE REVENUES SHALL BE USED AS SET FORTH IN ORDINANCE NO. 85.07 FOR CAPITAL IMPROVEMENTS AND DEBT RETIREMENT ON CAPITAL IMPROVEMENTS, FOR THE IMPROVEMENT, MAINTENANCE AND CONSTRUCTION OF CITY STREETS AND BRIDGES, FOR GENERAL MUNICIPAL OPERATIONS, AND FOR DEFRAYING THE COSTS OF COLLECTING THE TAXES LEVIED BY THIS ORDINANCE?
