






PROPOSED BOND ISSUE

CITY OF WESTERVILLE

A MAJORITY AFFIRMATIVE VOTE IS NECESSARY FOR PASSAGE

SHALL BONDS BE ISSUED BY THE CITY OF WESTERVILLE FOR THE PURPOSE OF PAYING COSTS OF PROVIDING ADDITIONAL FACILITIES FOR THE CONDUCT OF GOVERNMENTAL OPERATIONS BY CONSTRUCTING, RENOVATING, FURNISHING AND EQUIPPING, INCLUDING THE ACQUISITION OF FIRE APPARATUS, RELATED BUILDINGS TO HOUSE FIRE, POLICE AND OTHER ESSENTIAL MUNICIPAL FUNCTIONS, ACQUIRING REQUIRED REAL ESTATE AND INTERESTS THEREIN, PROVIDING FOR NECESSARY APPURTENANCES, AND MAKING NECESSARY SITE IMPROVEMENTS IN THE AMOUNT OF \$4,045,000 AND A LEVY OF TAXES TO BE MADE OUTSIDE OF THE TEN MILL LIMITATION ESTIMATED BY THE COUNTY AUDITOR TO AVERAGE ONE AND SEVEN-TENTHS MILLS FOR EACH ONE DOLLAR OF VALUATION, WHICH AMOUNTS TO SEVENTEEN CENTS FOR EACH ONE HUNDRED DOLLARS OF VALUATION, FOR A MAXIMUM PERIOD OF TWENTY YEARS TO PAY THE PRINCIPAL AND INTEREST OF SUCH BONDS?
